The Court of General Sessions, or General Sessions of the Peace was the basis of local government until the last quarter of the 19th century. The Court was composed of Justices of the Peace appointed by the Governor in Council. This system had been in operation in England.

The Court had administrative as well as judicial functions. These included the appointment of local officers, licensing of taverns, fixing of certain prices, levying of poor and county rates, and control over roads, bridges, prisons, hospitals, and other public works.
