Paper with Charles Morris' name on it.

1. The Honourable Charles Morris, Senior - memorandum respecting my Mortgage to him (most of the document has been destroyed or is missing).
2. Deed of sale of land owned by Charles and Elizabeth Morris, Junior to Henry Neal for property in the South Suburbs of Halifax, April 6, 1764.
3. Statement by Charles Morris, Junior that he had received the sum of one hundred and fifty pounds from Henry Neal for a house and lot.
4. Letter from Charles Morris, Junior to Joseph Pernette at LaHave - August, 1773 - letter concerns grants of land in Nova Scotia.
5. Letter from Charles Morris, Junior to Joseph Pernette - dated August 29, 1786 - letter regards "friendship".
6. Letter from Charles Morris to Joseph Pernette - dated October 19, 1786 - letter regards Morris and Pernette families.
7. Letter from Christopher Jessen from Lunenburg to Mr. Morris - letter concerns a wedding - dated November 11, 1786.
8. Letter from Charles Morris, Junior to Joseph Pernette, La Have - dated July 14, 1796 - Letter concerns the inquiry into the desertion of British soldiers.
9. Letter from Charles Morris, Junior to Joseph Pernetts, La Have dated December 27, 1796 - letter regards the circumstances surrounding sister Eagleson and her children.
10. Receipt - April 21, 1797 received of Mr. John Newforth thirty - five pounds two shillings due me, on Joseph Pernette esq. Bond for interest - signed Charles Morris.

11. Receipt - May 29, 1793 - Charles Morris received thirty-seven pounds from Joseph Pernette.
12. Envelope with the writing on the outside - "enclosing accounts and receipts from the Honourable Charles Morris, Esquire to May 10, 1798".
13. Memorandum of the money Mr. Pernette owes £ 632-3-3 $\frac{1}{4}$
14. Memorandum of Mr. Pernette's Bond to Charles Morris £ 636-11-1
15. Letter from Charles Morris, Junior from Joseph Pernette, La Have - dated Halifax, August 18, 1800 - letter touches various topics, namely, Pernette's trip, his sister Cuglisa?, land grants and the Napoleonic War.
16. Letter from Charles Morris to Joseph Pernette, LaHave - dated Halifax, October 28, 1800.
17. Letter from Charles Morris to Joseph Pernette, LaHave - Dated Halifax, November 18, 1800 - mentions holdings and the small pox epidemic.
18. Letter from Charles Morris to Joseph Pernette, LaHave - dated Halifax, February 7, 1801 - letter mentions that Charlotte (nee Pernette) Morris has had another son.
- 18A. Letter from Charles Morris to Joseph Pernette, LaHave - dated May 4, 1802 - letter refers to Charles' brother, William, being shipwrecked and to Charles' father's estate.
19. Letter from Charles Morris to Joseph Pernette, LaHave - dated October 8, 1803 Halifax - letter mentions the debt owed by Mr. McIntosh; and Charles and Charlotte Morris' sons, William and Charles.
20. Letter from Charles Morris to Joseph Pernette, LaHave - dated Halifax, November 4, 1802 - letter speaks of the rarity of cider in the community.
21. Receipt - 7 June 1803 - "Received of Joseph Pernette esq. By the hands of Mr. Isaac Wilkins the sum of Two Hundred Pounds Currency in part payment of principal and interest on his Bond and Mortgage to the Hon^{able} C. Morris Deceased"- Signed Charles Morris Executor.

22. Receipt of money paid by Garret Miller, Jacob Rowland, Casper Wollenhaupt to Charles Morris to be paid by him to his mother, 1805-1806.
23. Statement of money Joseph Pernette owed to the estate of the Honourable Charles Morris, June 25, 1801 and June 6, 1803.
24. Letter from Charles Morris to Joseph Pernette - dated October 21, 1803.
25. Letter from Charles Morris to Joseph Pernette, LaHave - dated January 13, 1804 - Charles Morris states in his letter that he hopes to take a vacation soon.
26. Letter from Charles Morris to Joseph Pernette, LaHave p - dated May 28, 1804 - letter concerns the birth of Charles and Charlotte Morris' daughter.
27. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated November 29, 1804 - letter concerns Fanny's death as a result of diptheria.
28. Letter from Joseph Pernette to Charles Morris, Junior - undated - letter regards Joseph Pernette's son, John; and land in Lunenburg County.
29. Letter from Charles Morris to Joseph Pernette, Lunenburg - December 1804 - letter regards Mr. Flieger surveying the land at the falls of LaHave to Miller Cook's land.
30. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated January 26, 1805 - letter regards the property dispute between Joseph Pernette and Miller Kock.
31. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated January 25, 1805 - letter regards property dispute.
32. Letter from Charles Morris to Joseph Pernette, Lunenburg - March 29, 1805 Halifax - letter regards property dispute and a group in England trying to deprive Morris of his job.

33. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated April 22, 1805, Halifax - letter refers to this continuing property dispute between Pernette and Cook and to the problem Morris faces as a group tries to remove him from his position.
34. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax July 12, 1805 - letter mentions the property dispute and a robbery in his chamber, of his business papers.
35. Letter from Charles Morris to Joseph Pernette - dated Halifax August 16, 1805 - letter states various problems which Charles Morris has encountered.
36. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated February 19, 1806, Halifax - letter regards a land grant .
37. Letter from Charles Morris to John Pernette - dated Halifax March 19, 1806 - Two hundred and fifty acres each are to be laid out and surveyed for John Smith and John Valentine Selig.
38. Receipt - dated Halifax, April 9, 1807 - "Received from J. Pernette esq. by the hands of Mr. Wollenhaupt Eight Pounds five shillings" - signed Charles Morris.
39. Receipt - dated February 5, 1806 "Please to deliver thirty pounds into the hands of the bearer John Liston being the sum put into your hands by Mr. Pernette to be paid to me". signed Charles Morris.
40. Balance due on [Joseph Pernette's] land to the Estate of the late Mr. Morris.
41. Letter from Charles Morris to Joseph Pernette - dated Halifax March 24, 1806 - letter regards Mr. Zouberbuhler's will and a land grant.
42. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax May 3, 1806 - letter mentions Charles Morris winning his court case which at that time had already cost him upwards of two thousand pounds.

43. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax, December 22, 1806 - letter mentions that Morris returned Pernette's keg filled with port wine.
44. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated February 8, 1807 - the letter mentions the poor health of Morris' mother, that Mrs. Morris will soon have another child and the Napoleonic War.
45. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax February 24, 1807 - letter mentions wine that Morris bought for Pernette, money Pernette owes Charles Morris' mother, and Charlotte Morris has had another baby.
46. Letter from Charles Morris to Joseph Pernette - dated Halifax, April 13, 1807 - letter mentions wine that Pernette bought from Morris, Charles Morris' (deceased) estate, surveyors for Lunenburg County and the Napoleonic War.
47. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax, May 11, 1807 - letter regards the disappointment Pernette has experienced since his land has not been surveyed, and the law suit between Pernette and Cook.
48. Letter from Charles Morris to Joseph Pernette - dated Halifax May 25, 1807 - letter regards Theophilus Chamberlain surveying Pernette's property at some future date.
49. Letter from Charles Morris to Joseph Pernette? - dated Halifax May 28, 1807 - letter regards land grants and surveys of properties in Lunenburg County.
50. Letter from Charles Morris to Joseph Pernette, Lunenburg - dated Halifax July 22, 1807 - letter mentions Pernette paying twenty-five pounds to Charles Morris' estate and apprehension regards a possible war with United States.
51. Letter from Charles Morris to Mrs. Pernette, Lunenburg - dated Halifax, November 30, 1810 - Morris sent Mrs. Pernette a grate stove, coal, sugar, wine, molasses, meal, flour and cocoa when it becomes cold he will send a fattened pig.
52. Pay Sheet for the 2nd Company of Halifax Militia Artillery - dated Halifax, December 18, 1807.

53. Letter to Miss Augusta Miller from Charles Morris. Invitation to a family dinner party.
54. Letter from John J. Morris to Charles Morris, Junior, Lunenburg - dated Halifax, December 8, 1823 - letter regards Charles Morris, Junior teaching school in Lunenburg County - Charles' father, John mentions, would like to see Charles ordained a minister.
55. Letter from Charles Morris, Surveyor General to Joseph Miller, Deputy Surveyor, County of Lunenburg - dated Surveyor General's Office, Halifax, February 16, 1830 - letter regards land grants in Lunenburg County.
56. Letter from Charles Morris, Surveyor General to Messrs. Fancy, Rhino, Smith and Becker, Lunenburg - dated Office of Commissioner of Crown Lands February 17, 1830 - Mr. Joseph Miller is to investigate and report on applications for land grants in Lunenburg County.
57. Letter from Charles Morris, Surveyor General to Joseph Pernette Miller, Deputy Surveyor, County of Lunenburg - dated Surveyor General's Office, Halifax, February 18, 1830. - Letter regards a two thousand acres land grant at Lunenburg for the purpose of a commons. This land is to be used for the benefit of a public school.

Letter from Charles Morris, Surveyor General to Joseph Miller, Deputy Surveyor - dated Halifax March 27, 1830 - letter states the cost for a land grant - twenty pounds for two hundred acres, one pound nine shillings for a licence of one hundred acres, and two pounds nineteen shillings for a licence of two hundred acres.
59. Letter from Charles Morris to Joseph Miller - dated Office of Commissioner of Crown Lands, May 8, 1830 - letter regards potential land grants in Lunenburg County.
