He says "we cannot get the necessary articles of life, without sending to distant parts for them; although the county around us is sufficient to supply us, if we had regular markets for the sale of them." He also asks that Archibald present another petition for Acts establishing markets in Halifax and Liverpool before the House. He adds that "It is needless to say, why we have not put these papers into the hands of our own members". He goes on to say that the Bills will be opposed by the merchants and shopkeepers who "would oppose any public measure, whatever benefit might accrue from it to the community, could they put one penny in their pocket by it". Aitken next directs Archibald's attention to the Law relative to District Schools. He generally approves of recent Legislative action in this area but says that it should be modified a little for the people of Lunenburg because "it point of civilization and mental improvement, (Lunenburg) is at least an hundred years behind any other part of the province". Aitken suggests two basic modifications for Lunenburg. First, he thinks it is essential that the clergy should be in charge of the "Superintendence of Schools". Secondly, and of essential importance, he thinks that English should be the only language spoken in the District Schools. He writes: "The present generation is the third which has been in this county since the first settlement of the French and Germans and yet many of them cannot speak a word of English" There cannot be a greater reproach to the Jurisprudence of the country than the exhibition of a Lunenburg jury, the generality of whom do not understand one word out of ten addressed to them by the Counsel and Judges."
