Statement of Robert Scott MacKay, age 16 yrs., residing at 225 Fulton Avenue, Westmount, C.B.

I was at St. Joseph's Dance Hall last Friday night. I was with Debbie McPherson, Keltic Drive and left the hall about 11:45 P.M. because she wanted to get the North Sydney bus home. We walked down to Wentworth Park. We were there for 5 to 10 minutes; so we walked up on to Crescent St. She noticed Sandy Seale lying down on the roadside. I went over. I noticed it was Sandy and I asked him what was the matter. He told me he was stabbed and he needed help. I told her to go get a bus and I ran and tried to find a person to help me. I ran across the Park up to Polletts and I found a boy named Livingston from East Bay. He was with a girl at the time. So we ran back down through the park and up to Crescent St., but by the time we were getting up to him a car slowed down and a Marshall boy got out. Junior said I was with him and he showed me his arm and so I told him we should to a house and call the police. He said No. So I talked to him and both of us went to a house there and I said "Call the Police. Jr. Marshall showed this man his arm. When we got back from the house, 2 police cars arrived.

So the Police questioned me and told me to leave. I went home with Bruce Butt from Westmount. I met him at Harris' corner after I left the scene.

Q. Did you ask Junior Marshall who stabbedthem.

A. Yes, he said a man with glasses and a younger man with him.

Jr. said the man with the glasses stabbed Sandy and said that is for you Buddy and then Jr. said he tried to get away and he stabbed him in the arm.

On the night of Sandy Seale's murder I was at the dance at St. Joseph's Hall. We left the dance and walked through Wentworth Park to catch a bus on Kings Rd., by Atlantic Spring. I was accompanied by a Debbie McPherson. While we, we were walking I Noticed Sandy Seale lying on the Crescent St., more towards the centre of the road. I bent over and asked him what the problem was. He told me that he was stabbed and wanted help. I told the girl to go to the corner to get the bus and I went in the other direction to get help. I ran across the park by Pollets Drug Store and met a Livingston chap from East Bay and told him that a guy was stabbed and that he needed help. We ran back across the park and when we did we saw a car stop by Seale's body and Junior Marshall got out along with other people and the car went on. First when I saw Marshall I said "Junior" and he said do you know me. I said yes Sandy has been stabbed He said I know he was with me.

Then he told me that two guys jumped him and Sandy. He showed me his arm and said look what they did to me. Then he showed me how the guy stabbed Sandy by putting his fist into my stomach. Then I said we'll better call the police. He said no. Then I said we better get help and he said yes and the two of us started walking towards a house. We went up to the house and they wouldn't let us use the phone so then we left and came down back to the body and when we did there were two police cars there. The police then put Junior Marshall in the back of police car. At that time I went home. I spoke to the police and gave a statement on June 2 when they called me to go to their office.

I didn't see anyone else in the park at that time.

There was a crowd of people gathering at the time the police arrived and they told us to go home.
