I need your assistance in having a review made of my case which has resulted in me being incarcerated and I need extra-ordinary help.

Briefly, I have been jailed for committing fraud against I.E.L. and DREE by altering invoices for equipment I sold to my company Mulgrave Pumps & Strainers Limited and which I.E.L. and DREE now say that I was not permitted to do as these were non-arm's length transactions.

Unfortunately I was instructed by the Representative of I.E.L., Mr. Tony Krauch to do this, and how to do it. In addition, he agreed to take care of any objections DREE might have to this process. The evidence at my trial showed cleary that both I.E.L. and DREE paid the invoices knowing full well these represented non-arm's length transactions. Also, there are what I consider to be irregularities in the conduct of the R.C.M.P. and Messrs. Stewart, MacKeen & Covert (I.E.L.) and the staff of I.E.L. and DREE.
